RE: 2012/2013 LAUC Assembly Report of the Research & Professional Development Committee

On June 13, 2012 the LAUC Research and Professional Development Committee forwarded to the Office of the President for final approval original copies of grants applications received, and an executive summary of the proposals for research grants, mini-grants and presentation grants submitted for the 2012-13 fiscal year. A total of nineteen grants proposals were received for review. During the review process five proposals were withdrawn. Research grant funds available for the 2012-13 fiscal year were \$24,300.00 for librarians in the bargaining unit and \$8,100.00 for non-bargaining unit librarians. The Committee recommended funding grant proposals totaling \$22,971.00.

On August 1, 2012, the Chair of R&PD received a letter from Susan Carlson, Vice Provost Academic Personnel on behalf of the UC Office of the President supporting the recommendations by the Committee to fund fourteen grant proposals in the total amount of \$22,971.00.

### **Research Grant Award Recipients**

#### **A. Jade Alburo**

*Discovering Southeast Asia: An Assessment of Major Southeast Asian Studies Collections in the United States*

Campus: UCLA

From the abstract: Because Southeast Asian Studies (SEAS) is a young discipline (beginning in the 1960s), there are only fourteen libraries with comprehensive SEAS collections in the US. These institutions are sustaining significant decreases in collections budgets, making an already challenging area for collection development even more difficult. With so many of these libraries having to focus monies on their core disciplines, many SEAS materials are consequently not being collected. Therefore, it is necessary for these libraries to begin thinking about collaborative collection development in order to ensure that a wide breadth of research materials is available to support the research needs of SEAS scholars.

#### **Matthew Conner**

*The New Library: Seven Trends, Four Case Studies*

From the Abstract: This book seeks to bridge theoretical and practical issues about the future of academic librarianship. The first half will summarize seven prominent trends of change in the profession in the areas of reference, personnel, technology, collections, buildings, campus roles, and library culture. While these trends have been discussed extensively, this book expects to contribute by providing an historical narrative for each that identified driving forces, identifies best practices and promising directions, and shows the complex intersections between the topics. It is hoped that this methodology will provide a useful framework for the vast and multiform discussion of the future of libraries.

*A Bibliography of Viticultural and enological Publications from the Former Yugoslavia*

From the abstract: I am compiling a comprehensive bibliography of publications (both scholarly and non-scholarly) on viticulture and enology published in the former Yugoslavia (I have currently identified over 2000 citations.) My stay in the successor states of the former Yugoslavia will be devoted to consulting library collections, along with the department and institutes that specialize in viticulture. I plan to make my finished bibliography accessible electronically, so that the rich scholarly, scientific, and popular literature on grapes, wine, and wine-growing and making from the former Yugoslavia may better inform international scholarship: the University of California's open-access eScholarship platform for scholarly publishing is an excellent means of disseminating research to a global audience.

*Underground Printing in communist Poland, 1976-1990*

This is a continuation and expansion of my research on underground printing and publishing in communist Poland, 1976-1990. In August-September 2011, as the Lasner Fellow in Printing History, I travelled to Poland to gather materials on independent printing under communism. I conducted interviews with prominent printers of the "Solidarity" movement and studied documentary materials. That trip resulted in a paper delivered at the American Printing History Association's annual conference, then turned into a scholarly article, a series of lectures, and an exhibit at Mills College. Yet the wealth of materials I brought back from Poland is far from being exhausted, and to pose even more questions that need answers. My follow up research will concentrate on clarification of many details and acquiring new information regarding the organization and logistics of printing, obtaining paper, ink and other printing components, distribution of printed matter, etc.

Last year, the Committee once again offered LAUC Mini-Grants and Presentation Grants in addition to traditional Research Grants.

1. Review the recommendations and communications from last year's committee or other group identified by the LAUC President to identify specific issues and concerns, suggest, and implement, wherever possible, procedures to clarify and simplify the Mini & Presentation Grant proposal procedures.
2. Continue to monitor its experience with the three different grant types, report any issues, concerns or problems, and recommend possible solutions.
3. Collect and post outstanding grant reports from 2009, 2010, 2011 and 2012 grant recipients.

- Revised and distributed 2012-13 Call and Calendar to the membership on October 23, 2012.
- Use confidential website for distribution of proposals to members.
- Currently in final review stage of process of submitted proposals to be funded 2013-14 fiscal year.

- Contact previous Research Grand Award Recipients (2009, 2010, 2011, 2012) to determine the current status of the research projects and as necessary solicit a final report or final project as required in Section IV. J. and Section VI of the Guidelines specifically.
